Council is composed of one Reeve, 4 Councillors for Ward One, and 2 Councillors for Ward Two.

JUST A REMINDER OR IF YOU HAVE RECENTLY MOVED...

As tax statements will be processed in the next few months, we remind you to contact the Administration Office if you have had an address change in the past year to ensure that we have the correct mailing address on file.

If you are a Manitoba resident and property owner of a single dwelling unit as of January 1st and if this is your primary residence you may qualify for a Manitoba Education Property Tax Credit on your tax statement of up to \$700.00.

If you do not receive the credit application forms can be filled out at the administration office. Please call for further details and information required by the Province to process the request.

WE NOW OFFER A TAX INSTALLMENT PAYMENT PLAN for those residents who would like to pay their property taxes via pre-authorized payments. Please call the Admin Office for more information or to set up your account.

PUBLIC WORKS DEPARTMENT

A listing is being compiled for those rural residents who wish to receive **dust-proofing** for 2014. The minimum distance for the application is 300 ft. with the cost remaining at \$1.00/lineal ft. Registration and full payment **MUST** be received in the office on or before May 30th to receive the dust-proofing application. For further inquiries contact the public works department.

Please be reminded that **empty lots/properties must be maintained** on a regular basis. Unkempt properties may be cleaned up without prior notice at a charge to the owner.

The **weed spraying program** is continuing for 2014 in municipal ditches. Property owners with any concerns or questions should contact the Public Works Department.

Residents are urged to drive with caution as the municipality begins with the annual **gravel recovery program** this spring. The program saves tens of thousands of dollars each year and we appreciate your understanding and patience during this process.

Drainage on private property must be licensed by MB Water Stewardship. RM public works staff can assist you with this process.
