# Recyclable Guidelines

- Accepted Recyclables:**
- Aluminum – Beverage cans, trays, foil, pie plates & other containers
  - Box Board – Single layer such as cereal, tissue boxes
  - Cardboard – Corrugated
  - Glass – Food jars & Beverage containers. All broken glass should be put into the garbage.
  - Milk jugs
  - Milk & juice cartons/boxes, tetra-pak containers
  - Paper – Newspapers, flyers, inserts, junk mail, office paper, materials such as letter quality paper, envelopes (with or without windows), copier paper, computer printouts, paper egg cartons, phone books, paperback or hardcover books, magazines, catalogues, bagged shredded paper, brown paper bags, tissue roll cores, gift and packing paper
  - Plastics with Recycling Logo #1, 2, 4, 5, & 7 such as pop/water bottles, laundry detergent jugs, shampoo bottles, condiment bottles, food containers such as yogurt, margarine, etc.
  - Tin Cans – soup, ketchup, etc.

- Please remember to:
- Empty and rinse all containers
  - Flatten cardboard boxes

- Not Accepted:**
- #3 Plastics (e.g. PVC kids toys, pipes.)
  - #6 Plastics (e.g. styrofoam, CD cases.)
  - Bubble Wrap
  - Disposable Diapers
  - Fluorescent Bulbs/Light Bulbs
  - Household Hazardous, Bio-hazardous, Chemical Waste Containers (Accepted at the City of Winkler Public Works Yard – 345 1st St.)
  - Medical Waste (Prescription Pills, Syringes, Bio-Hazardous Material)
  - Outdoor Lawn Furniture
  - Paint/Paint Cans
  - Photos (Glossy Paper)
  - Plastic Bags

- Plasticized, Waxed, or Laminated Material
- Propane or Helium Tanks
- Pyrex or Dishware Glass, Window Glass,
- Mirrors, Ceramics, Porcelain
- Rubber Tires
- Scrap Metals
- Styrofoam/Styrofoam Packing Material
- Vinyl Siding
- Wood Waste/Pallets
- Wrapping Paper that is glossy/shiny



# Hazardous Household Waste Guidelines

**Pesticides:**  
Liquid, solid and aerosol pesticides. The maximum container size is 10 litres. The maximum aerosol container size is 680g / 24oz. To be accepted, the product label must have: The poison symbol (skull and crossbones), the Pest Control Product (PCP) number, the word ‘domestic’

**Toxics:**  
Liquid/aerosol products - product label must show the poison symbol (skull/crossbones) and the word ‘danger’. Ex: Automotive additives, furniture stripper, lubricants, tar/bug remover.

**Corrosives:**  
Liquid, solid and aerosol corrosives. The container label must display the corrosive symbol. Examples: Grout cleaner, masonry cleaner, pool and hot tub cleaners, rust remover.

**Flammable liquids (including gasoline):**  
Liquid and aerosol flammables. The container label must display the flammable symbol. Gasoline will be accepted only in a ULC-approved gas can or jerry can. For safety reasons, the gasoline container cannot be returned to you at drop off. Examples: Gasoline, including stale or old gasoline contaminated with oil or water, methanol, paint stripper, paint thinners, paint and varnish remover, turpentine, kerosene.

**Physically hazardous products:**  
Products with a label displays both the flammable symbol and explosive symbol. Examples include non-refillable fuel cylinders such as: Non-refillable butane cylinders, non-refillable camping cylinders, non-refillable propane cylinders.

**NOT Accepted Products**  
Unidentifiable, unknown, unlabelled, and non-original containers, leaking or improperly sealed products, ammunition, batteries, caulking compound, cleaners (eg. drain opener, bleach), commercial, industrial or agricultural products, cosmetics and health or beauty aids, diesel, drugs, medicines, and medical sharps, fertilizer, insect repellents, disinfectants and pet products, mercury switches, oil/antifreeze, powder forms (solid) of masonry products, cement, grout, mortar, plaster of Paris, refillable propane cylinders, swimming pool chemicals (eg. pucks, pH adjustors), wine and distilled spirits.

- All Sealed Single and Rechargeable Batteries. No Automotive Batteries
  - Cameras/Audio -Video Devices
  - Cell Phones/Phones/Answering Machines
  - Computers/Keyboards/Mice/Monitors/Video Gaming Peripherals
  - Cables & Conductor Wires
  - DVD Players, VCR's
  - Fax Machines
  - IT Devices
  - Laptops
  - Medical & Monitoring Devices
  - Microwaves
  - Photo Copies, printers, scanners
  - Stereos
  - TV's
